APPLICATION REQUIREMENTS

- 1. Fill out the application form completely, sign and date. Type or print legibly. Respond to every question and submit any supplemental materials.
- 2. Applicant must already be a senior in high school or entering their senior year; attending an undergraduate program or be enrolling for the upcoming fall semester.
- 3. Applicant must provide a current resume and official school transcript.
- 4. Applicant must provide two letters of recommendation. One must be from a Tae Kwon Do Master instructor, or your instructor, and the second may be from a teacher, faculty member, employer or other individual knowledgeable with the applicant's character and qualifications. Family members and relatives are ineligible.
- 5. Applications must be received by 7/31/2022 which is the 5th Sunday of the month.

The letters must be typed, signed, and dated, and include the person's name, title, address, phone number and relationship to the applicant. Give the recommender a several week notice to write the letter. The recommender must send the letter(s) directly to
